### WITHDRAWAL FROM THIS WEEKEND TRIP

- If a trip participant withdraws from this trip, the trip participant may lose the entire payment upon withdrawal. If the participant can be replaced from a waiting list, the participant will be refunded the entire payment less any costs incurred by the trip organizer.
